## **POSITION SUMMARY:**

As part of the Swan Lake First Nation Health Care team, the Jordan's Principle Communicable Disease Control (CDC) Unified Referral Intake Services (URIS) Nurse is responsible for applying public health science, and nursing theory to promote, protect and preserve the health of populations. The CDC-URIS nurse would strive to improve the health of all children and reduce inequities by addressing determinants of health and promoting equitable health outcomes.

- Assist in coordinating comprehensive client services.
- Coordinate communicable disease case/issue management in the community.
- Coordinate the school immunization program.
- Assess the deficits with service systems and the need to service children through early intervention, sharing of information, effective coordination of services and appropriate training.

- Collaborate, network, and cultivate partnerships to ensure a comprehensive referral network for community resources.
- Facilitate provision of education and training for staff, students, and community.
- Develop and implement processes to support appropriate health care responses to children with identified needs,
